**Paragraph 25 shall be edited as follows:**

The authorized capital of the bank is UZS 255 000 000 000 (two hundred fifty five billion) and is distributed into the following shares:

ordinary registered shares – in the amount of 255 000 000 (two hundred fifty five million) pieces, with a par value of UZS 1 000 (one thousand).

The amount of shares declared by the bank that the bank can issue in order to increase the authorized capital is 300 000 000 000 (three hundred billion), including:

ordinary registered shares - in the amount of 250 000 000 (two hundred fifty million) pieces, with a par value of UZS 1 000 (one thousand) each.

preferred shares - in the amount of 50 000 000 (fifty million) pieces, with a par value of UZS 1 000 (one thousand) each.
